



### 2 Enrollment


- 2. Log in to the APP Store, download and install the App.



Medical Alarm	Set the panic button as medical button via the AX PRO client. Press the button to trigger the alarm while in emergency condition. The LED keeps red for 2 s.	
Panic Alarm	Press the two buttons synchronously to trigger the alarm while in emergency condition. The LED keeps red for 2 s.	
Medical Alarm	Set the panic button as medical button via the AX PRO client. Press the two buttons synchronously to trigger the alarm while in emergency condition. The LED keeps red for 2 s.	

### 6 Formatting

Remove the battery. Hold any button for 8 seconds and meanwhile put the battery in . The red LED flashes 3 times when the formatting is completed.

### 7 Set up with App

You can view the device status including temperature, signal intensity, battery level, connection, 24-hour zone, and operation mode on the device page. Tap the button to enter the settings page.

Function	Description
Zone Type	Select the zone type of the detector.
Enable Silent Zone	Slide to green to make the zone keep silent while alarm is triggered.
Cross Zone	If the alarm triggered in both of the linked zones within the set time, two alarm messages will be reported.
Link Camera	Link with a camera for intruder verification.
Accidental Press Protection	Set the protection mode to prevent from false alarm.
Polling Rate	Set the interval of heartbeat.
